

Chubb TravelEase Travel Insurance Supermarket Coupons Offer Terms and Conditions



1. The Chubb TravelEase Travel Insurance Premium Discount and Supermarket Coupons Offer ("Promotion") commences on 29 October 2024 to 31 January 2025, both dates inclusive ("Promotion Period").
2. To enjoy the Promotion, Customers are required to fulfil the following requirements:
 - a. During the Promotion Period, successfully enroll Chubb TravelEase Single Trip Travel Insurance (Executive Comprehensive Plan) or Chubb TravelEase Annual Travel Insurance (Executive Comprehensive Plan) ("Eligible Plans"); and

安達旅無憂旅遊保險超級市場現金券優惠條款細則

1. 安達旅無憂旅遊保險保費折扣超級市場現金券優惠（「優惠」）的推廣期為 2024 年 10 月 29 日至 2025 年 1 月 31 日（包括首尾兩日）（「推廣期」）。
2. 客戶須符合以下要求以享受優惠：
